The Ad-Hoc Reporting module enables users to define and customize reports that meet individual department and reporting information requirements. In addition, the Ad-Hoc Reporting module delivers a reporting environment that is completely practical, allowing users to dynamically modify and query report data to gather useful business information for budgeting, return on investment and other risk managed models.

### Multi-level Access and Flexible Security

The Ad Hoc Reporting module integrates seamlessly into the iTrak desktop maintaining existing iTrak data security, ensuring relevant and confidential data access is overlaid and maintained in the reporting environment.

### Report Wizard

The primary goal of Ad Hoc Reporting Module is to allow not only "power users", but even the "casual user", to easily design and execute reports. The New Report Wizard is designed to walk users thru all of the required steps in creating a new report, from designing the layout, to selecting filters and sort sequencers, to selecting the output mode (e.g.: Excel, HTML, CSV, PDF, RTF).
